Latest developments


Storm Christoph struck the country and has dissipated, but it generated <u>an Amber Warning from the Met</u> <u>office</u> as heavy rain affected parts of Peak District. I know every site has revisited its plans to cope with the potential impact of such bad weather.

The work that has already been done in anticipation of such situations is testament to the importance and quality of the planning which has gone into this vaccination programme.

All fifteen PCN-led vaccination sites are continuing their excellent work, including vaccinations on site, in care homes and for housebound patients.

Vaccination sites and centres across the Midlands have continued their outstanding efforts, vaccinating more than 700,000 people. That figure is the highest for any English region.

Next Steps

A group of pharmacy-led vaccination sites will be opening across the Midlands this week, followed by a second wave next week. This second wave is expected to include three sites in Derbyshire, and a further four sites are being discussed for a future wave of openings. Work is also underway to open a mass vaccination centre at Derby Arena, operating alongside the PCN site already running.

The work to prepare these venues is detailed and demanding, and it is vital for the safe, effective delivery of vaccinations for thousands of people.

Vaccine updates and initial FAQs

Should I contact my GP or hospital to arrange getting the COVID-19 vaccination?

- No. When it is the right time people will receive an invitation to come forward.
- For most people this will be a letter, either from their GP or the NHS National Booking Centre. This letter will include all the information you will need to book appointments, including your NHS number.

What is Swiftqueue and can I use it to book a vaccination appointment?

- Some GPs are using a system called Swiftqueue to arrange the date and time of vaccination appointments for patients they have identified as being among the highest priority to receive the COVID-19 vaccine.
- You should only use a Swiftqueue link if you have been personally sent the link when offered an appointment by your GP practice
- Vaccination site staff will check that patients qualify for a vaccine, and will refuse entry to those who have booked an appointment inappropriately
- The current cohort of patients being offered vaccines is made up of four risk groups:

- Residents in a care home for older adults and staff working in care homes for older adults
- o Frontline health and social care workers
- All those 80 years of age and over
- All those who are clinically extremely vulnerable individuals (not including pregnant women and those under 16 years of age)
