INCREASE YOUR DONATION FOR FREE - *giftaid it*

The tax office can increase your donation if you pay income tax. This means we can reclaim the tax without any cost to you by ticking the Gift Aid box. Our Charity can reclaim the tax on all donations through the Gift Aid Scheme with no added cost to the person making the donation. Currently we can claim 25p in every £1 - that's a further £2.50 on every £10 given.
